Eligibility to appear for Professional examinations

Attendance

1. The learner must have a minimum of 75% attendance in theory and 80% in practical /clinical
2. In subjects that are taught in more than one phase - the learner must have 75% attendance in theory and 80% in practical in each phase of instruction in that subject
3. There shall be minimum of 80% attendance in family visits under Family adoption programme
4. Foundation Course, Electives, and AETCOM are compulsory part of the curriculum and 75% attendance as well as submission of log book maintained during elective is mandatory for eligibility to appear in the final MBBS examination
5. If an examination comprises more than one subject (for e.g., General Surgery and allied branches), the candidate must have a minimum of 75% attendance in each subject including its allied branches, and 80% attendance in each clinical posting.

Internal assessment

1. Internal assessment shall be based on day-to-day assessment, records, log books as well as regular periodic examinations conducted throughout the course.
2. When subjects are taught in more than one phase, the internal assessment must be done in each phase and must contribute proportionately to final assessment.
3. An end of posting clinical assessment shall be conducted for each clinical posting in each professional year.
4. Prior to the University examination a model examination in the pattern of University examination will be held, the results of which will be included for internal assessment of the students.
5. Learners must secure at least 50% marks of the total marks (combined in theory and practical / clinical: not less than 40% marks in theory and practical separately)

Pass criteria

University Exams

A candidate shall obtain

- ❖ minimum of 40% marks in University Theory examination*
- ❖ minimum of 40% marks in University Practical/Clinical
- ❖ Minimum of 50% marks in aggregate (**Theory + Practical/ Clinical combined**) to be declared as passed in that subject.

*In subjects that have two papers, the learner must secure at least 40% marks in aggregate (both papers together)

Internal assessment marks will not be added to University Exam marks and will reflect as separate head of passing at the summative examination.

NEXT Examinations

As per NEXT Regulations

Progression through phases

At the end of each professional year university examination will be conducted.

If any student fails to clear university examination, he will appear in supplementary examination.

Supplementary examinations and declaration of results shall be processed within 3-6 weeks from the date of declaration of the results of the main examination every professional year.

A candidate, who fails in the First Professional (University) examination, shall not be allowed to join the II MBBS, he shall join the batch of next academic /subsequent year.

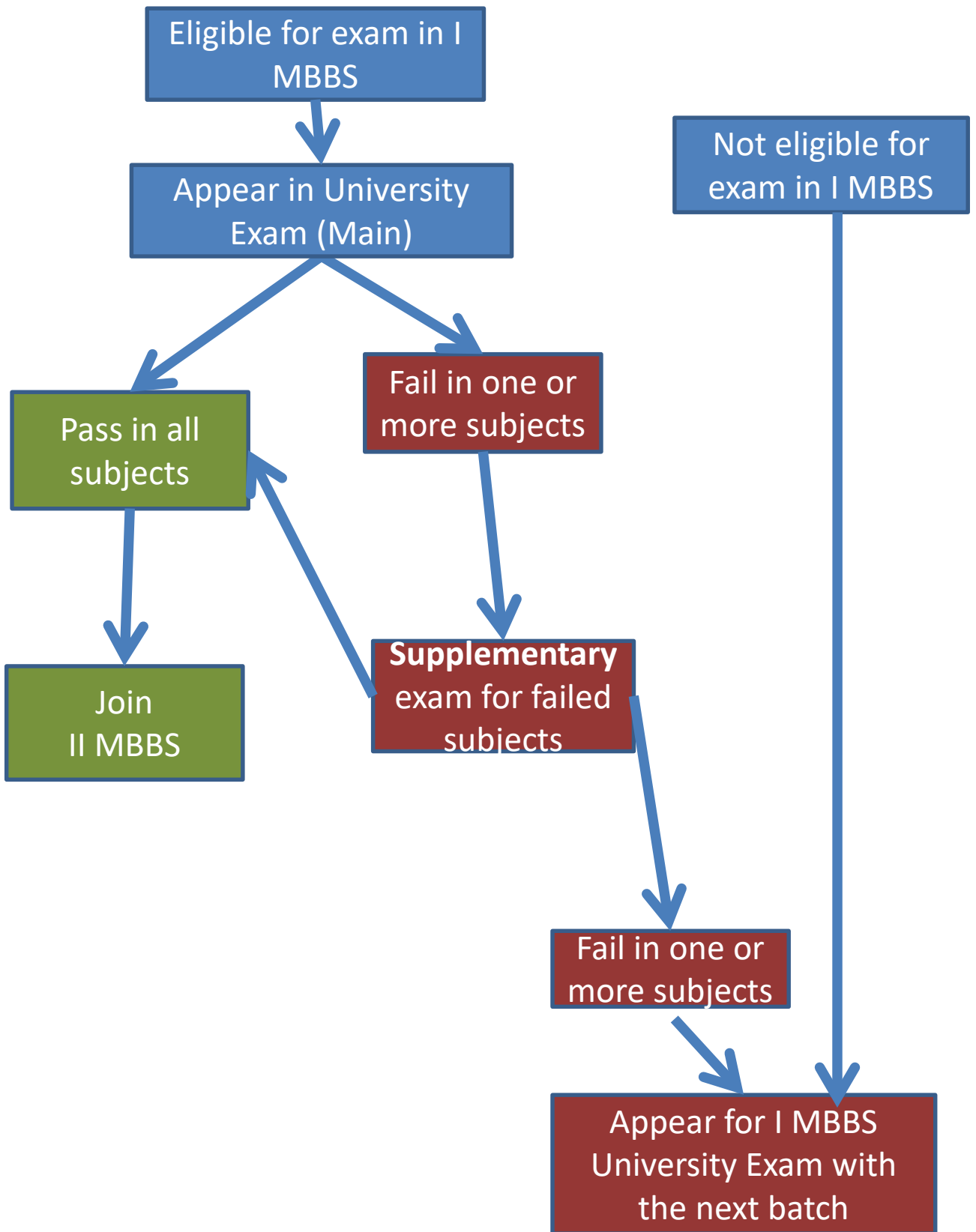
A candidate, who fails in the second Professional (University) examination, shall be allowed to join the third Professional Part I training, however he shall not be allowed to appear for the examination unless he has passed second professional examination.

A candidate who fails in the third Professional (University) - Part I examination shall be allowed to join third Professional part II training, however he shall not be allowed to appear for the examination unless he has passed second professional examination.

A clarification was received from the National Medical Commission, New Delhi, dated 10.01.2023, regarding the criteria for the candidates to appear for the Supplementary examinations, which states as follows:

(i) If a candidate is not eligible for main exam, he cannot be eligible for Supplementary Exam.

(ii) If a candidate is eligible for main exam, but does not appear in it/ fails in it , he/she can be allowed to appear in supplementary exam.



How to track your progress

Department

1. The monthly attendance summary are put in the notice board
2. The Internal assessment test scores are put in the notice board
3. Periodically departments may track the students' progress and communicate to the students or parents, when required.

Academic mentors

1. Mentors meet the students at a designated hour to review the performance of the students
2. Mentor-mentee discuss regarding the academic performance, any difficulties faced, action plan for future etc.,
3. Mentors may also communicate with parents any academic/ non-academic issues faced by their wards

Academic cell

1. Parents are informed by post the details of their ward's progress- every 3 months
